This DM regrets that The Journalist magazine has been out of print for more than one year, after the printed option for the April/May edition in 2020 was suspended during the first

DM recognises the necessity of a union publication for NUJ members and the continued relevance of The Journalist as a resource and a membership benefit.

As recently reported in The Journalist, the NUJ has 6,730 members over 60, including those who are in receipt of state pension or who are unemployed. Further, the union has been

working for almost two years to campaign for 60+ members to have access to the digital space and to get online.

DM recognises the prevalence of online media but also that a digital divide means some of its members do not have easy or regular access to the union's resources via online means. DM further recognises the impact of internet overload and the need for members to read away from the computer for personal and health and safety reasons.

DM also recognises that The Journalist, in reaching members' homes rather than depending on internet access and engagement, is an essential and effective communication tool. DM further recognises the potential to undermine the union's defence of print, and to promote an uncritical move to online only, if it fails to defend its own print publications. One example of the benefits of a print edition is the standalone photography feature "The Story behind the Picture" which is better seen in print to enable a full page view at a reasonable size, and which in addition can be kept in print as an example of the work that our members do.

As such, DM recognises the necessity to support and continue printing The Journalist for members who want and need it, to ensure their continued inclusion and reach in communication.

This DM further notes the resolution passed at DM 2018 which instructed the NEC to enable The Journalist to remain a print publication, publishing a print edition at least six times a year.

This DM instructs the NEC to return The Journalist to offering a print option alongside the digital option, and publishing at least six editions a year with a print option, as soon as practicable or at any rate by the start of the new NUJ financial year in September 2021.
