Who should join the NUJ?

Journalists including photographers, creative artists working editorially in newspapers, magazines, books, broadcasting, public relations and information, and electronic media; or as advertising and fashion photographers, advertising copywriters and editorial computer systems workers.

How should I pay?

We strongly recommend that you complete the direct debit form above. If you decide to pay by cheque you should enclose the first quarter's contribution with your application.

What happens next?

Your application will be acknowledged within 10 days of receipt. It will then be referred to your local branch. On election, you will be sent an application form for a National Press Card and full details of the union's benefits and rules.

How much will it cost?

As of 1 October 2016 the cost of full membership is based on your current annual earnings. There are three grades, listed below.

Grade 1: Members earning up to €24,000 per annum
€216 per annum / €18 per month

Grade 2: Members earning between €24,001 and €36,000 p.a.
€276 per annum / €23 per month

Grade 3: Members earning over €36,000 per annum
€372 per annum / €31 per month

No member should pay more than 1 per cent of their gross taxable income in NUJ contributions subject to a minimum rate of €11.50 a month (€138 a year).

Reduced Contributions

Any member earning less than €15,640 should only pay the minimum rate. If you think that you are eligible for reduced contributions, please complete the declaration on page 2 of this form and enclose evidence of your income.
